

MC CARTY::: lot 16 con. 5, & 6 N.R. north of Millers Creek.

Lot 16 Con.5 & 6 was deeded to Benjamin Hardison from the Crown
Feb. 10th., 1797 56 acres.

Jan 8, 1798 Benjamin Hardison released the land
to Joshua Fairbanks : 140 acres.

Mar. 1802 Joshua Fairbanks & wife Sophia sold to
John Miller 150 acres lot 16, in the 5 & 6th.
& lot 10 in Willoughby.

Apr. 24, 1834. John Miller sold to daughter Anna Mc Carty
wife of Alfred Mc. Carty : 40 acres: S.E. part
of lot 16, in the 5th., & 6th., con.

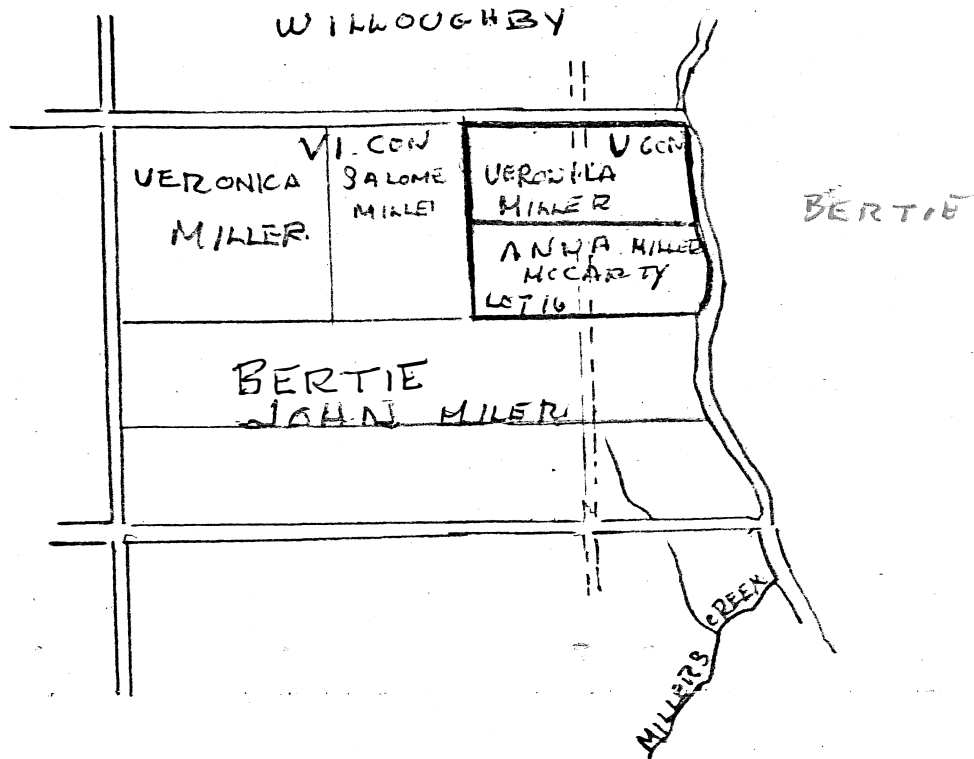
The old Miller home still stands on the N.E. cr. of lot 16, con 5.
(1982) and tradition has it that a log cabin , stood here before it.
Whether this home was built for Veronica , or Anna is a question left
unanswered by time. Veronica Mc.Afee did get the east end of lot 16
from her father John at the same time , as Anna received her lands.
We know that the Mc Carty family lived in this home, as on Regt.
print out Veronica and Daniel Mc. Afee sold the land to Alfred.
Again Alfred sold to his his Rolph Mc. Carty, who lived upon the
land before moving to the U.S.A.

Anna & Alfred had three girls and one boy John Rolph. He was
named after the aid of William McKenzie, and after the Rebellion
the Mc. Carty's and their relatives the MC Afees, also sympathizers
with MC. Kenzie were not very popular among their neighbours. John
Rolph , Samuel MC Afee and other familie members left for the U.S.A
and other parts of Canada.

There are several of this family buried in the MC. Afee Cemetery,
however the original stones are beyond reading. A new stone , marking
their graves has been installed. You will note that the name has
been changed by adding an H., making it Mc.Carthy.

Apr. 24, 1834: ::: Willoughby: east side of lot 11 in the Cross con.
Beginning in Willoughby at the distance od one chain from the Niagara
River at a willow tree: and at a distance of about ten chains , from
the north east angle of the said lot 11: thence south thirty chains
fifty links more or less to an allowance for a road between the Townships
of Bertie and Willoughby: thence east seven chains forty five links
more or less to the allowance for a road between lot no.eleven and ten:
thence north twenty three chains more or less, to within one chain of the
Niagara River.:thence north westerly along the said River, always
at the distance of one chain from the said river, to the place of the
