READ THE TERMS AND CONDITIONS OF THE CONTRACT

Should there be any failure to promptly pay such note for deferred payments or should there be any default in any deferred payment, the full amount remaining unpaid of the purchase price shall become due and payable immediately upon such default, and you, or your agent, may take possession of and remove said Account Register and appurtenances thereto delivered and take out and remove my accounts therefrom without legal process, unless an extension of time be granted by said International Register Co., in writing, and all payments previously made shall be considered as having been made for the use of said Register during the time the same remained in the custody of the undersigned.

It is further agreed that the title to said Register shall not pass from International Register Co. until the same, or notes given for same, shall have been paid for in full, and that until such time said Register shall remain the property of said International Register Co. It is also agreed that the bringing of any suit for the price of said Register shall not operate to vest the title thereto in the undersigned, but said Register shall remain the property of said International Register Co. until any judgment recovered for its price shall have been paid. In case of recovery by legal process, all court costs and attorney's fees shall be paid by the purchaser whose name is hereunto attached.

The undersigned hereby expressly waives as against this agreement all exemptions and homesteads, and all claims for damages, and further expressly waives any and all provisions of law wherein and whereby it is required, any sum of money shall be repaid to the undersigned, or that said property shall be sold at public or private sale upon notice to the undersigned, and that any part of the proceeds shall be accounted for or paid over to the undersigned. Nothing contained herein shall prevent International Register Co. from taking such legal action as they shall think fit for recovery of the money agreed to be paid hereunder.
