JOHN BIRCH(BURCH) MILLER (1792-1872.)

John Burch Miller was named for John Burch, miller at Niagara Falls Ontario; and benefactor of Andrew Miller( 1766- 1843). He married Elizabeth Miller, daughter of John Miller and Christianna Miller :: from the north side of Millers Creek Niagara River Road. They moved to St. Thomas between 1820-1825; where he was given a land grant as a son of a U.E.L. . Their graves are in the cemetery surrounding the old Anglican Church in St. Thomas.
