

JACOB BENNER: lot 4 concession 3, L.E.

1802; Crown to Constantine O' Neil: 4&5 all 200 acres.

1804: Constantine O' Neil to John Warren: 226 acres.:
consisting of lot 4 in 1st., 2nd., and 3rd., concessions.

1813: Willed by John Warren Sr. to his wife Julia during her
life & after to his dght. Julia lot 4 in the 1st & 2nd.,
cons. from lake Erie with broken front.

1836: Apr. John Warren only son and heir of Late Julia (Warren) Hall
22. deceased dght. of John Warren granted to Richard Graham
174 acres::: no. 4 in the 1st & 2nd. & east $\frac{1}{2}$ of No. 4 in
the 3rd. ::: These lands were said to be in the 4th.,
fronting on Lake Erie and 4 in the 1st., and 2nd. cons.
however 1 is 1st., 2nd. & 3rd. cons. ::: compare description
with plan of the Township of Bertie.

1839. Dec. 21st. John Hall granted unto JACOB BENNER JR. for \$75.

12853 50 acres west $\frac{1}{2}$ of lot no. 4 in the 2nd. con.::: these
lands are said to be in the 2nd. con. but as the Garrison
road is on the north end they would appear to be in the
3rd. con.

1844. Apr. 13th., Richard Graham granted unto JACOB BENNER JR.
2001 50 ACRES, E $\frac{1}{2}$ of lot 4 in the 2nd con.: or 3rd range
from Lake Erie. \$ 200.

1879. Dec. 20. Jacob B. Benner willed to Philip E. Benner &
John his two sons. 100 acres and to Philip E. & Wm.
Hedley his executors.

1880. Jacob & Julia Benner: executors. A Stevens wife,
relinquishes her legacies, of Philip E. & John Benner.

1901. June 3. Philip E. Benner & wife grant to Hedley Benner 8 acres
composed of the west part of lot # 4 beginning at the
s.w. corner of lot #, thence east, running south side
of the Garrison Rd. 10 chains--- to the lands of
John R. Benner: thence south along said lands 86 chains
to a stake: thence west 40 chains to a rd. allowance
between Lot 4 & 5: thence north 8 chains to the place of
the beginning.

1915. John B. benner to Albert M. Benner 50 acres; e $\frac{1}{2}$ of
lot # 4 \$1. and life lease.

1938. Oct. 22nd. W. Hedley Benner & wife sold W $\frac{1}{2}$ of lot 4 to
Franklin E. Benner: 50 acres.

1948 Albert M Benner + wife to Matthew A Schnitker
