

There is no mention in the crown deed of lot #4 N.R. ever being owned by Samuel Mc.Afee: In 1802 the land went from the Crown to John Wintemute, and was sold to Benjamin Hershey in 1805. Tradition states otherwisw as the Mc. Afee family were living just north of this land on the Cr. pf Thompson road and the river road. They were living there at the time of the rebellion in 1837, and helped WM L. Mc.Kenzie to escape to the U.S.A. Shortly hereafter, because of dislike & abuse by other settlers in the area they returned across the border, and are not buried in Mc. Afee cemetery.

Just back from the river facing Thompson road, stood the old Weslyn Methodist Church. Wallace Stockdale the son of Wm. bought the old church in 1890, and had it taken down in 1900. He proceeded to build a large frame farmhouse and drive shed, almost where the church had stood. He used the beams from the church to construct the driveshed, which stood to the south of the homestead closer to Thompson Pd.

When the Niagara Parks commission decided to widen the river road in the early 1940's, the old homestead had to be removed. The last members of the Stockdale family lived on the farm till the house came down in 1943.

Wallace 1866 - 1940

The deed herein from the Welland Registry Office quotes the land transfered as:::

"being by admeasurement 80 acres, being part of lot # 5 in the first cross con. N.R. "known as follows: beginning at the north east corner of the lot, thence south to within ten feet of the Weslyan Methodist Church, thence west fifty feet, thence south ninety nine feet, thence east fifty feet, thence south to the road allowance between the said cross concession, and lot # ten: thence west twenty chains more or less to the land conveyed by the said Samuel Mc. Afee and Sophia to Joseph Doner: thence north forty eight chains more or less, to within one chain of the Niagara River: thence easterly, always at the distance of one chain from the said river twenty chains more or less to the place of the beginning.
