

ANDREW MILLER::: lot 14, in the 5th., con. & lot 14, in the 6th., con.N.R.  
Came to the Province in 1778, and petitioned for land  
in 1795. Kept a tavern on the Niagara River at the  
Junction of the Ridge( Miller Rd. ) where town meetings  
were sometimes held.

Andrew Miller devised to Peter Miller : 200 acres, lot no. 6. & 7  
in the 4th. con . Township of Bertie. Welland County.  
to Andrew Miller Jr. : lot 14, con. 6, Bertie Township.100 acres.  
also he divided to Andrew Miller Jr., a piece of land where  
he now lives:( lot no. 14, his homestead farm)

Composed of: " the south east angle of lot 14, in the 5th., con.  
of Bertie aforesaid: The said parcel of land is bordered in the front by  
the Niagara River: in the south by a Creek running south easterly; until  
it intersects a branch and ravine running north westerly: across the road  
between lots no. 14, & 15: in the fifth concession containing 20 acres,  
more or less.

to Benjamin Miller: lot no. 12, in the 5th., con.: containing 100 acres:  
also the east part of lot no. 13: and the south east  
angle of lot no. 14, including all the land lying  
south east of the road, which crosses the said lots  
commonly called the Ridge Road.

to son Edward::: lot 13, in the 6th. con., containing 100 acres.  
also the west end of lot n. 13, in the 5th., con.  
north west of the said road leading to the Ridge:  
and also the remainder of lot 14, in the 5th. con.  
together with the buildings and the remainder of the  
lot: is bounded in front by the river, south east by  
the road leading to the Ridge aforesaid.: north west  
by a Creek and Ravine till it strikes the road between  
lot 14, & 15: which Creek & Ravine is boundary between  
his, and sons Edward & Andrew: and west by the Con. in  
the rear of the said lot.

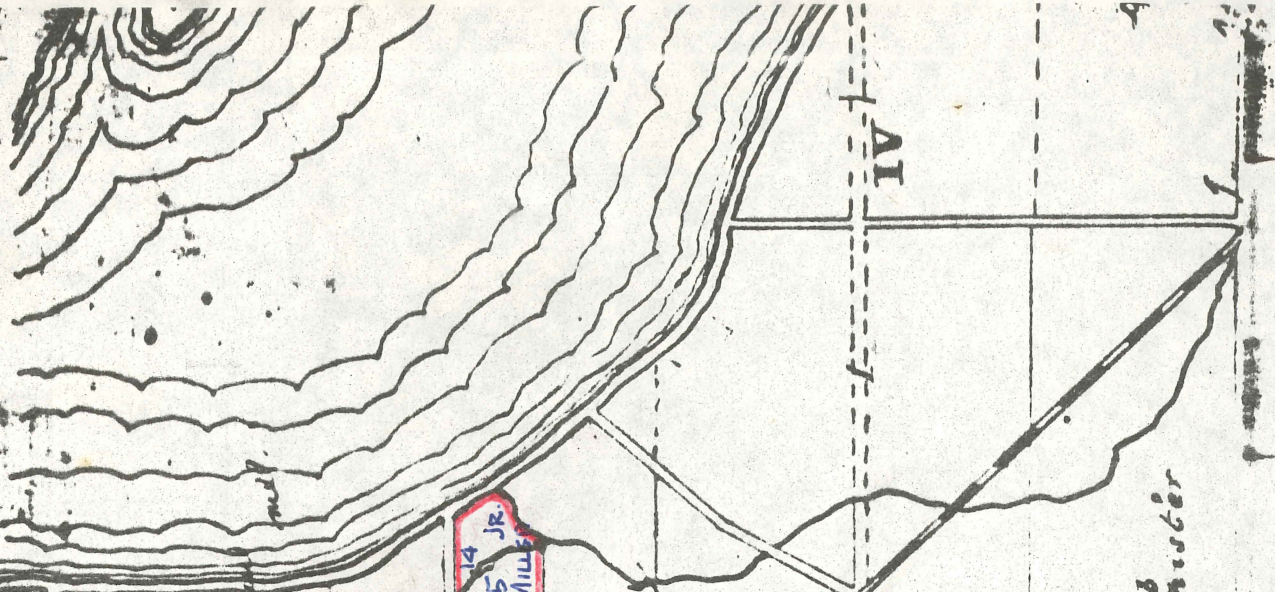
